Sealaska Remediation Services awarded 5-year, \$20.9 million contract



From large, groundwater-protecting construction projects to cleaning up dangerous pollutants, Sealaska's businesses have worked on environmental and infrastructure improvements with the United States Army Corps of Engineers (USACE) for many years. Sealaska Constructors has been providing design and construction support to the Bureau of Indian Affairs at Haskell Indian Nations University in Lawrence, Kansas, since 2020. To date, we have delivered \$32 million in construction across more than 30 buildings and outdoor sports and recreational facilities. The work includes building science labs and making building systems such as heating, ventilating and air conditioning (HVAC), plumbing and electrical more current and efficient, saving energy and reducing waste. The overall campus improvements provide a healthy, comfortable learning environment for Indigenous students who attend the university.



# New acquisition expands portfolio of sustainable seafood businesses

In March, Sealaska added Norwegian white fish trading company Normarine to its Woocheen family of sustainable seafood businesses. The high quality and sustainability of Norwegian seafood is central to Woocheen's premise that relying on responsibly harvested, ocean-based foods are a powerful way to care for oceans and the planet. Normarine expands the company's ability to provide markets with high-quality Atlantic cod and haddock, alongside Alaska line-caught Pacific cod.

## SEALASKA ANNOUNCES \$1.1 MILLION IN 2023–2024 SCHOLARSHIP AWARDS

Sealaska is invested in education. We are proud to announce that more than \$1.1 million in scholarships will be awarded to 462 recipients for the 2023–2024 academic year. Scholarships will support shareholders and descendants pursuing degrees on either a full- or part-time basis, as well as those enrolled in vocational-technical programs.

"By supporting students on their path to education and beyond, we are investing in future leaders, an investment with perhaps the greatest return of all," said Sealaska President and CEO Anthony Mallott. "Every scholarship represents an inspired learner. We are proud to support them, and proud of all their current and future accomplishments." Sealaska partners with Sealaska Heritage Institute (SHI) to award hundreds of merit-based scholarships to our community's future leaders every year. Funding comes from the investment performance of Sealaska's scholarship endowment fund, established in 1989 through a \$2.5 million commitment. In 2018 and 2020, the board approved additional commitments of \$10 million and \$2.5 million, respectively. In 2022, the board approved an additional \$8.4 million.

"The increased funding is fortuitous as we are witnessing a trend in an increasing number of scholarship applicants," said SHI President Rosita Worl. "The increased funding is also meeting a need to fund part-time students."

To date, Sealaska has committed more than \$27 million to its scholarship fund and awards more than 400 scholarships per year. The annual American Indian Science and Engineering Society (AISES) Leadership Summit, which took place this year from April 30–May 2, is a spring conference that brings hundreds of Indigenous students and leaders together to share knowledge, wisdom and understanding.

Sealaska sponsored five students from across the United States to attend, providing both financial and mentorship support as they navigated the summit. The following students attended:

- Maddie Henson is graduating this spring with a degree in neuroscience from University of Vermont.
- **Taylor Heaton** is pursuing a bachelor's degree in earth and atmospheric sciences at Cornell University.
- **Randy Estrin** is pursuing a bachelor's degree in business administration at Haskell Indian Nations University.
- **Taylor Natkong** is a Codefy program participant from Hydaburg, Alaska.
- Alegandro Aguirre is a Codefy program participant from Everett, Washington.

Participant Taylor Heaton will be working to assist Sealaska Heritage Institute in ongoing underwater exploration in submerged caves off the shore of Prince of Wales Island this summer in addition to a Sealaska internship in New Mexico. Her AISES experience has led to greater connection with culture as well as helped inspire her to apply for Sealaska opportunities. "I feel a lot more connected to Alaska

Heaton hopes to see more shareholder students take advantage of opportunities offered through Sealaska sponsorship to attend AISES and other conferences, increasing representation. She is currently working on a session proposal for next year's summit that is Alaska Native-focused.

Participant Maddie Henson, who served as her alma mater's student body president and graduated last month with a degree in neuroscience, shared similar sentiments. "AISES has meant the world to me over the past four years," she said. "It's truly changed my life, being able to be with other Native students and meet with other young Native professionals. AISES has helped me find community and see excellence in each other and in ourselves as young Native people."

AISES creates a community that welcomes Indigenous students and helps them develop and attain their career and education goals through scholarships, conferences, internships and mentorship opportunities.
